2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: highly filled water based styrene acrylate dispersion containing dispersant, coalescent, microbiocide and thickeners

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.
